²These figures account for total funds including both state and federal matching components. It should be noted that the federal medical assistance percentage (FMAP) for each state is different, indicating variation in the delineation of state and federal funds between states with the same total dollar investment in GME.

³The investment from Georgia to match the per capita rate of other states is also represented in total funds and does not account for which of these funds are state general funds vs federal matching funds. The preliminary FY2025 FMAP is 65.84.
